**4. Chairman's Announcements**

**a) Temporary Traffic Regulation – Rusper Road**

Notification has been received from WSCC that Rusper Road between its roundabouts with Giblets Way and Kings Road will be temporarily prohibited on Monday 16<sup>th</sup> June 2014 from 9.30am for 4 days. This closure is to allow carriageway patching to be carried out.
