1. Public Forum

The Public Forum will last for a period of up to 15 minutes during which members of the public may put questions to the Council or draw attention to relevant matters relating to the business on the agenda. Each speaker is limited to 3 minutes. Business of the meeting will start immediately following the public forum or at 7.45pm whichever is the earlier.

3. Declaration of Interests

Members are advised to consider the Agenda for the meeting and determine in advance if they may have a **Personal, Disclosable Pecuniary or Other Registrable Interest** in any of the Agenda items. If a Member decides they do have a declarable interest, they are reminded that the interest and the nature of the interest must be declared at the commencement of the consideration of the Agenda item; or when the interest becomes apparent to them. Details of the interest will be minuted.

If the interest is a **Disclosable Pecuniary Interest**, Members are reminded that they must take no part in the discussions of the item at all; or participate in any voting; and must withdraw from the meeting chamber, unless they have received a dispensation.

Where you have an **Other Registrable Interest** (which is not a Disclosable Pecuniary Interest), Members are reminded that they must withdraw from the meeting chamber after making representations or asking questions.

ii. Enhanced Partnership Statutory Stakeholder Consultation

In March 2021, the government published a new **National Bus Strategy (Bus Back Better)** which sets out its vision to dramatically improve bus services in England, reverse the shift in journeys away from public transport as a result of Covid-19 and encourage passengers back to buses.

The West Sussex Enhanced Partnership will set out how they will deliver the outcomes of their Bus Service Improvement Plan, published in October 2021 following engagement with the public, operators, and other key stakeholders. Members are advised that this information was circulated to all

Members by email and it is suggested that individuals are free to respond as they wish, rather than by way of a Committee Decision.

HDC advised that an Appeal has been lodged in relation to DC/22/1249 - 6 Yarrow Close, Horsham, for the change of use of land to residential to provide enlarged residential curtilage and erection of fencing to provide enclosure to land. This application was considered under the Parish Council's Scheme of Delegation at the meeting on 18th August 2022. The comment submitted was "*Objection; The proposal grabs land that is intended to form the open plan nature of the development.*




Title: 002 SITE LOCATION PLAN
