1. Public Forum

The Public Forum will last for a period of up to 15 minutes during which members of the public may put questions to the Council or draw attention to relevant matters relating to the business on the agenda. Each speaker is limited to 3 minutes. Business of the meeting will start immediately following the public forum or at 7.45pm whichever is the earlier.

3. Declaration of Interests

Members are advised to consider the Agenda for the meeting and determine in advance if they may have a **Personal, Disclosable Pecuniary or Other Registrable Interest** in any of the Agenda items. If a Member decides they do have a declarable interest, they are reminded that the interest and the nature of the interest must be declared at the commencement of the consideration of the Agenda item; or when the interest becomes apparent to them. Details of the interest will be minuted.

If the interest is a **Disclosable Pecuniary Interest**, Members are reminded that they must take no part in the discussions of the item at all; or participate in any voting; and must withdraw from the meeting chamber, unless they have received a dispensation.

Where you have an **Other Registrable Interest** (which is not a Disclosable Pecuniary Interest), Members are reminded that they must withdraw from the meeting chamber after making representations or asking questions.

5. Chairman's Announcements

- i. Members may recall an item on the Agenda for the PET Committee Meeting on the 27th June 2024 (PET/025/24), about road safety concerns and parking issues regarding Lambs Farm Road. Members **AGREED** that to improve road safety along Lambs Farm Rd, they would want to see the slowing down of traffic. This could mean the installation of safe pedestrian crossings/traffic islands, the installation of Speed Indicator Devices (SIDs), speed loops to be put down to show excessive speeds, a reduction in speed to 20 mph along the whole road or part of it where speeding is worse. Members want to explore the use of SIDs further by contacting neighbouring Councils who have some in place, together with Sussex Police, and report back regarding the potential for a Community Speedwatch group.

On the 4th July 2024, the Committee Clerk contacted the Clerk at Trafalgar Neighbourhood Council to take advantage of their offer of any useful information regarding the slowing down of traffic, and for advice on the SID's scheme, and to ask if it would be possible for a meeting between our Chairman of this Committee, Ray Turner, and our Parish Clerk and possibly the Committee Clerk, with the HTNC Clerk and one of their Councilors. The Committee Clerk followed up on this on Tuesday 13th August 2024.

- ii. The Parish Office has been contacted by WSCC to advise of a PROW Annual Inspection within the Parish. The Access Ranger will next month be undertaking the inspection of all PROW in the Parish. As circulated to all members by email on 14th August, any maintenance issues need to be referred to the Ranger before the end of August and therefore, anyone with any comments or issues for highlighting, has been advised that these must be submitted to the Clerk by **Tuesday 27th August**. Whilst not an actual maintenance issue, the Clerk has already highlighted the Community Highways Scheme application that has been submitted by a resident for FP1584 which crosses the railway line from Treadcroft Drive.
- iii. The Parish Clerk has been notified that, with regard to the Gatwick Airport Northern Runway Project, the Examining Authority has published a further letter, which contains questions to the Applicant (Gatwick Airport Limited), easyJet, IAG/British Airways, the Civil Aviation Authority (CAA), NATS (En Route) Plc (NERL), Thames Water, the Surrey Hills AONB Board and all Interested Parties - <http://infrastructure.planninginspectorate.gov.uk/document/TR020005-003240>

The questions to "All Interested Parties" relate to the Carbon Budget Delivery Plan and the Carbon Cap Scheme. With responses due by 27th August, and as these issues have never formed part of the Parish Council's previous comments/concerns, it is not intended to make any comments.

- iv. The Parish Office was recently made aware of a caravan being parked in a layby on Honeysuckle Walk and found that it has been there for some time. The Clerk notified West Sussex County Council Highways and on Wednesday 14th August, received the following reply:

Decision: To note the Schedule of Planning Decisions made by Horsham District Council since the last meeting in respect of previous applications.

9. Community Litter Pick

Members may recall that this matter was previously discussed at the PET Committee Meeting held 25th April 2024 (Min. PET/134/24 refers) with the members being in favour of working together on this agreeing that the idea would be supported, and further information was requested which is as follows :-

- i. HDC would be willing to loan the equipment needed including litter picking sticks, hi viz vests and bags. Unfortunately, HDC no longer issue gloves for hygiene reasons and therefore a box of 200 surgical gloves would need to be purchased and a budget identified for this.
- ii. The only proviso to loaning the equipment is that those taking part are covered by parish Public Liability Insurance (PLI). The Council's insurers have confirmed that Volunteers, Councillors and employees undertaking activities on behalf of the Parish Council, such as litter picking, are covered automatically by the policy under the Employers' and Public Liability sections. If aged over 16 and under 90 they are also covered by the Personal Accident section where there is a sum of £100,000 payable in the event of an accident causing death, loss or limbs or sight or permanent total disablement. A £500 weekly benefit is payable for a maximum period of 2 years should the accident prevent the individual from pursuing their usual occupation.

- iii. In order to reduce the likelihood of injury or damage arising the insurers recommend that a risk assessment of the proposed tasks is completed in writing and kept on your records and a copy is attached as **Appendix 3**.
- iv. A meeting was held with a representative from St Marks Church who suggested that the event start at the church with those picking litter returning to deposit their collections to the Church at a time to coincide with one of the Heart Café sessions.
- v. With regards to dates, Autumn was suggested when vegetation has begun to die back and allow more litter to be visible and therefore, the proposed date is Tuesday 15th October between 10am and 12noon.
- vi. The activity will be promoted by both the Church and the Parish Council via usual communications including social media. It was also suggested that in addition to all Parish Councillors, County and District Councillors be invited to join in which will also give an opportunity to meet with their electors.
- vii. There would need to be a Health & Safety Briefing before attendees set off and a copy of this is attached as **Appendix 3a**.
- viii. The Council will speak to HDC cleansing team about making arrangements for the collection of the bags after the event. In addition, HDC to be asked if it is possible to separate the rubbish in to recycling and non-recycling.
- ix. The suggested roads to be picked are shown on **Appendix 3b**.

Noting the above and the Appendices, Members are asked to agree whether a recommendation should be made to Council to proceed with the event, under the cover of the Council's PLI noting the Risk Assessments and Health & Safety Briefing.

Decisions:

To agree any recommendation to Council regarding working in partnership with St Mark's Church for a community litter picker on Tuesday 15th October 2024, noting that this would be under the cover of the Council's PLI supported by the Risk Assessments and Health & Safety Briefing.

To identify a budget of £50 for the purchase of disposable gloves.

10. Pedestrian Crossing on North Heath Lane

Members may recall a Chairman's Announcement at the PET meeting on 23rd May 2024, regarding contact with the Parish Council from a local, young resident with concerns about the safety of crossing North Heath Lane. The young resident asked for the Council's support in having a crossing installed opposite St Mark's Church. Following liaison with the Chairman of the Council and the Chairman of this Committee, the Clerk responded to the resident and contacted Cllr Andrew Baldwin. A meeting was set up at the area of concern for Tuesday 13th August 2024, with the young resident and their parent and the Chairman of the Council and the Chairman of this Committee.

Decision: To discuss the request from a local resident for a Pedestrian Crossing to be installed on North Heath Lane and agree to any further action.

11. NALC Consultation on NPPF Changes

The National Association of Local Councils (NALC) is seeking views from local (parish and town) councils and county associations of local councils (CALCs) on the government's proposed reforms to the National Planning Policy Framework (NPPF) and other changes to the planning system.

The Ministry of Housing, Communities and Local Government has published a consultation seeking views on its proposed approach to revising the NPPF in order to achieve sustainable growth in the planning system. The consultation also includes wider policy proposals in relation to increasing planning fees, local plan intervention criteria and appropriate thresholds for certain Nationally Significant Infrastructure Projects.

To help inform the development of a submission to the government on the consultation, NALC has launched its own online survey to gather views and insights from local councils and CALCs.

The online survey is part of wider work by NALC to promote and support local councils in the proposed planning reforms. This will include engagement with government ministers, officials and key stakeholders, dedicated meetings and events, and further briefings and updates.

The link to the [government consultation document](#) can be found here and should be read in conjunction with completing NALC's online survey.

You can find the [NALC's online survey here](#) and the closing date for responses is Monday 9th September 2024 at 12.00 noon.

Please be aware that the survey is lengthy with 114 questions to answer and requires some detailed responses. There is an option to complete as a body corporate or as an individual Officer/Councillor. If the option is chosen to complete as a body corporate, we would need at least six Councillors to send their responses to the Clerk by Thursday 29th August 2024. The responses would then be collated into one document which would go to the next Full Council meeting for ratification on Thursday 5th September 2024.

Decision: To consider any responses to the Consultation and agree on the option of how to respond to the survey.

12. North of Horsham Parish Liaison Group

As Members will know, meetings of the North of Horsham Parish Liaison Group have previously been held online. However, it has been suggested that the next meeting which is scheduled for late October/early November, be held in person. Members are therefore asked to agree that a suitable day time slot can be identified to hold the meeting here at Roffey Millennium Hall.

Decision: To agree that a daytime meeting of the North of Horsham Parish Liaison Group can be held at Roffey Millennium Hall in late October/early November.

13. S106 - Proposed Application from HDC for Release of funds

Horsham District Council's Recycling & Waste Team are requesting the release of Section 106 funding for use towards their project - the reorganisation of waste, recycling & garden waste rounds to optimise routes, accommodate new build properties and plan for future services.

As part of a new process for HDC applications for Section 106 funding, they are seeking the views / comments of parishes on proposed projects before making a formal application for funding.

Details of the S106 extract are shown below, and as can be seen, the definition for the usage of the funds is restricted to the provision or improvement of refuse and recycling facilities or services in the District of Horsham.

Bring with you/wear:

- 1) Protective gloves (e.g leather, gardening gloves)
- 2) Sturdy shoes
- 3) Appropriate clothing for weather conditions (e.g waterproof jacket, sun hat, sun block)
- 4) Long sleeves and long trousers
- 5) Drinking water
- 6) Mobile phone to contact co-ordinator if necessary

Hygiene:

- 1) Protect any cuts with waterproof plasters
- 2) Avoid rubbing the mouth and eye area while working
- 3) Wash hands and forearms before eating, drinking, smoking, using the toilet

Litter picking on roads

- 1) **High visibility clothing/tabards to be worn at all times**
- 2) **Main roads - litter pick on pavements only**
- 3) **Only competent adults to be involved**
- 4) **No personal music players to be used**
- 5) **No roads to be picked where no pavement is available**

Hazardous items: if you come across any of the following, report them to your co-ordinator, **do not pick them up**. If in doubt - leave it

- 1) Any needles/syringes
- 2) Any knives/blades
- 3) Unidentified drums, cans or canisters
- 4) Poisons, insecticides
- 5) Clinical waste
- 6) Condoms
- 7) Broken glass
- 8) Other hazardous substances (e.g suspected asbestos)
- 9) Animal faeces

Do not litter pick:

- 1) On main roads (only on pavements)
- 2) Near unstable banks of ditches/ponds or any boggy wet areas
- 3) Near electric fences (identified by yellow warning signs)
- 4) In streams, bodies of water (you risk catching leptospirosis from water contaminated by rats urine)
- 5) On private land, building sites or business premises

Bending/lifting/twisting:

- 1) Do not lift large/heavy/awkward items (contact your co-ordinator)
- 2) Only carry a manageable weight in the bin bag
- 3) Beware of repetitive injuries while bending and twisting - use your litter picker, remember this is only a litter pick not a rubbish collection

Only work in pairs or part of a group and always use your litter picker - **if you cannot safely reach the litter, leave it**
